**TERMS OF EXHIBITOR AGREEMENT**  
**RELEASE AND INDEMNITY AGREEMENT**

In consideration of the rights granted or to be granted to the undersigned to exhibit at the South Carolina Morticians Association, Inc.'s 96th Annual Convention, the receipt and sufficiency of which is hereby acknowledged, the undersigned exhibitor hereby agrees and shall protect, indemnify, defend and save SCMA harmless from and against all liabilities, losses, damages, costs, expenses (including without limitation reasonable attorney fees and expenses) causes of actions, suits, claims, demands or judgments of any nature or when so ever arising from (A) injury or death of any person, or damage to or loss of property, or any other thing occurring in connection with the services provided by the exhibitor, and (B) any violation of this agreement by the exhibitor, and (C) any negligence or misconduct of the undersigned exhibitor, its agents, employees, servants, heirs, subcontractor, administrators and assigns. The exhibitor/vendor (hereinafter referred to as Exhibitor) shall defend, indemnify] and hold harmless the South Carolina Morticians Association, Inc. In any and all claims against the SCMA Host, its agents, or employees by an employee, agent, servant, heirs, administrators, assigns, subcontractor or anyone directly or indirectly employed by the Exhibitor, or anyone for whose acts they may be liable this indemnification obligation shall not be limited in any way by any limitation on the amount or type of damages, compensation or benefits payable by or for the Lessee Exhibitor or any subcontractor under workers compensation acts.
